Pursuant to Regulation 29(1) (a) read along with Regulation 47 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirement) Regulations, 2015, please be informed that the Audit Committee Meeting and Board Meeting of the Company will be held on Monday, 5th November, 2018 to inter alia, approve the Unaudited financial results of the Company for the quarter ended on 30th September, 2018.
